ADMISSION TEST NOTICE FOR B.P.A. PROGRAM: 2022-23

Under the Department of Rabindra Sangit Dance & Drama and Hindustani Classical Music Sangit Bhavana

In continuation of the admission notification of the Visva Bharati for the academic session 2022-23, candidates who have qualified CUET and registered for admission in UG (BPA) course in the different subjects under the Department of Rabindra Sangit Dance & Drama and Hindustani Classical Music, Sangit Bhavana, Visva Bharati are informed that admission test (Online) date has been extended till October 31, 2022, Time: 23.59 for the applicants who could not submit their Video performance through Google Form.

Admission Test will be held on November 1, 2022.

Note: Those who have submitted their video performances through Google Form, no need to submit again.

Admission Test Modalities for B.P.A. Program

(Dept. of RSDD & HCM, Sangit Bhavana)

- 1. Admission tests for all courses of B.P.A. under the Department of Rabindra Sangit Dance & Drama and Hindustani Classical Music will be conducted online through Google Form submission by the candidates.
- 2. Google Forms will be sent separately to the candidates through their E-mail (mentioned as in the application) to upload their two Video Performances.
- 3. Video performance submission through Google Form will only be entertained for the admission test procedure.

Requirements to upload by the Candidates as mentioned below:

- 4. Upload two Videos in Mp4 (video format) of your own performance. Ensure it should not be more than 10 MB each and the duration of the video should be approx. 03 minutes each.
- 5. Avoid HD recording.
- 6. Program Recording and Studio recording will not be accepted.
- 7. It should not be edited (Audio/Video) by any means for presentation enhancement.
- 8. In Video recording face recognition is mandatory.
- 9. The last date of Video performance submission will be finalized by the departmental admission committee. Submission will not be entertained after the last date and time.
- 10. Applicant's image files should not be more than 1MB.
- 11. If you are shooting a video of your performance through Mobile and found it is more than 10 MB, now you have two options to minimize the size of your video –

b. Go to Google and type 'video compressor online' – compress your video online as required – check its size and upload.

APPLICANTS SHOULD FOLLOW THE GIVEN GUIDELINES

For Rabindra Sangit & Hindustani Classical Music

- Send your recording by using manual Tanpura/Electronic Tanpura or App only. Accompaniment of Harmonium will not be allowed.
- For Tabla accompaniment Electronic Tala Mala/App may be used, if Tabla accompanist is not available.

For Instrumental Music (Tabla, Pakhawaj, Sitar & Esraj):

- Nagma accompaniment is mandatory for Tabla and Pakhawaj applicants. In case of unavailability of Sarangi or Harmonium etc., electronic Nagma may be used.
- Tabla accompaniment is mandatory for Sitar and Esraj. For Tabla accompaniment, Electronic Tala Mala/App may be used, if Tabla accompanist is not available.

For Manipuri Dance/ Kathakali Dance/ Rabindra Nritya:

- Send videos of your own performance of any Indian classical dance/ Rabindra Nritya.
- Full body recognition is mandatory during the performance.
- Do not send any edited video
- Do not send any previously recorded performance video.

For Drama & Theatre Arts:

- One video of Self-introduction and any type of recitation or sight-reading.
- One video of Solo acting in a short scene.
- Full body recognition is mandatory for acting and recitation.
- Don't choose or enact/represent something that goes against the ethos.
- Do not send any edited video.
- Do not send any previously recorded performance video.
